

COUNCIL MEETING APRIL 21, 2020 7:00 P.M. STATHAM COMMUNITY CENTER 336 JEFFERSON STREET, STATHAM, GA 30666

1. CALL TO ORDER:

The regular business meeting of the City of Statham City Council was called to order by Mayor Joe Piper at 7:00 p.m.

Members present were Mayor Joe Piper and Council Members Tammy Crawley, Betty Lyle, Dwight McCormic, Hattie Thrasher, and Gary Venable. Also in attendance was attorney Jody Campbell, City Clerk Susan Gabriel, and Public Works Director Sam Powell.

Mayor Piper opened the meeting with the Pledge of Allegiance.

2. APPROVAL OF MINUTES:

Gary Venable said a correction should be made to the March 17 minutes. Page 3, New Business item 3 states that Gary Venable made a motion to adopt the Pandemic Policy and *Purchasing* Policy. It should read "Gary Venable made a motion to adopt the Pandemic Policy and *Credit Card* Policy."

Gary Venable made a motion to approve all of the minutes with the correction to the March 17 minutes. Tammy Crawley seconded the motion, unanimous.

Mayor Piper asked to amend the agenda to move New Business item C. City Attorney to number 3.

Tammy Crawley made a motion to amend the agenda. Gary Venable seconded the motion, unanimous.

3. CITY ATTORNEY

Mayor Piper asked the council for their support to name Jody Campbell as the new City Attorney.

Tammy Crawley made a motion to hire Jody Campbell as Statham's City Attorney. Betty Lyle seconded the motion, unanimous.

City Attorney Jody Campbell was sworn in by Mayor Piper.

4. OLD BUSINESS:

A. A RESOLUTION AUTHORIZING THE TRANSMITTAL OF A PROPOSED COMPREHENSIVE PLAN AMENDMENT TO THE NORTHEAST GEORGIA REGIONAL COMMISSION AND REQUESTING ITS FAVORABLE CONSIDERATION

Gary Venable pointed out that the Council is just transmitting the future land use map to the Regional Commission and is not adopting the map. Corrections can still be made before adopting the comprehensive plan amendment, which includes the future land use map.

Dwight McCormic made a motion to adopt the resolution to transmit the proposed Comprehensive Plan Amendment to the Northeast Georgia Regional Commission. Gary Venable seconded the motion, unanimous.

5. NEW BUSINESS:

A. CLEAN UP DAYS, MAY 15-16, 8 A.M. - 6 P.M.

There was discussion about the American Legion's Ride for the Fallen on the same day as the proposed clean up days. Dwight McCormic suggested using Casto's lot for clean up instead of Railroad Street. Mayor Piper said he would ask the Casto's about using their lot.

Dwight McCormic made a motion to approve the May 15-16 clean up days. Betty Lyle seconded the motion, unanimous.

B. SET DATE FOR BUDGET WORKSHOP

Mayor Piper said City Accountant April Plank has made progress and should have raw numbers soon. Discussion followed.

Hattie Thrasher made a motion to have a budget workshop on May 4 at 6:30 p.m. Gary Venable seconded the motion, unanimous.

C. CITY ATTORNEY

Tammy Crawley made a motion to go into executive session for the purpose of discussing pending litigation. Hattie Thrasher seconded the motion, unanimous. The council went into executive session at 7:56 p.m.
